Introduction

The Carers (Scotland) Act 2016 came into effect on 1st April 2018. The Act extends and enhances the rights of carers. The legislation helps ensure better and more consistent support for both adult carers and young carers. Education and training for carers is one of the areas included under part 6 of the Act.

There are currently estimated to be around 800,000 unpaid carers in Scotland. In 2022-23, the Scottish Funding Council reported that there were 21,520 student carer enrolments across the 24 colleges in Scotland.

Ayrshire College aims to provide an inclusive learning environment that is responsive to the needs of all students. We recognise that many of our students have to deal with the demands of caring for a friend or relative whilst studying, and we are committed to removing barriers to learning for students who have caring responsibilities.

This Action Plan outlines the steps we will take from 2024-27 to improve how we identify, support and report on the achievements of Student Carers at Ayrshire College.

Principle 1: Identity

Carers are being proactively identified and awareness is being raised throughout the College.
